MAIL SERVICE AGREEMENT AIR ICS

This service agreement is to provide mail services to the customer on Saba, Dutch Caribbean by Island Communication Services, hereinafter called "ICS", **for airfreight only**. Customer understands that "ICS" facilities and services may not be used for any illegal or illegitimate purposes prohibited by U.S. and Dutch Caribbean (postal) regulations. Customer further agrees to use the "ICS" services or any other facilities in conformity with all applicable local laws. This agreement between "ICS" and the customer shall remain confidential and will not be disclosed except when legally mandated. Possession of valid ID shall be considered valid authorization to remove any mail, packages or other contents received by "ICS" under customer's name.

All services are due and payable upon receipt. Service may be terminated at the option of "ICS", thirty (30) days after due date. If necessary arrangements are not made for the forwarding of mail when the agency relationship has expired, is canceled or is terminated, the customer's mail may be returned to sender or destroyed.

PLEASE NOTE: HAZARDOUS MATERIALS ARE PROHIBITED. Should we received hazardous materials at the address below, you will be notified and materials will be shipped to Saba by ocean. Transshipment charges and Ocean freight charges including administrative charges will apply.

PLEASE NOTE: No C.O.D. items will be accepted. As customer's authorized agent for receipt of mail, "ICS" will accept accept packages from common carriers such as UPS, FedEx, DHL, etc. In the event customer refuses to accept any such mail, customer shall pay postage and all other fees associated with refusal and return.

Customer agrees to protect, indemnify and hold harmless "ICS" from any and all claims, demands, and causes of action arising out of or in connection with the use of any services provided by "ICS", including, without limitation, any demands, claims and causes of action for personal injury or property damage arising from such use; from failure of the U.S. and local postal service to deliver on time or otherwise any items (mail, parcels, etc.); from damage to or loss of mail by any cause whatsoever and from any violation by customer of all applicable laws.
